In pursuance of the decision of the High Power Committee in its meeting held on 23.8.2010 and Govt. Memo No. 17095/SME dtd. 24.9.10 and as per the guidelines issued by the Govt. in the Department of School & Mass Education, Odisha, Bhubaneswar vide Resolution No. 30720/SME dtd. 23.9.96 Permanent No Objection Certificate is granted in favour of **ST. Arnolds School, IDC ByPass, Jhartarang Via-Panposh, Rourkela-4 Dist-Sundergarh** to open an un-aided High School upto Class-X which is to be affiliated to CBSE subject to the following terms and conditions.

1. The No Objection Certificate now issued shall be subject to the terms and conditions as prescribed in G.O No. -30720/SME dtd. 23.9.96 and No. 29519/SME dtd. 26.9.1998 read with G.O No. -10011/SME dtd. 11.6.2004
2. The school shall be open for inspection by the Inspection Committee.
3. No Financial assistance and Grant-in-Aid (both recurring & non-recurring) will be claimed by the institution from the Government at any point of time for meeting the salary cost and its component towards teaching and non-teaching staff appointed by the Managing Committee or for meeting any other expenses for managing the school.
4. The High Power Committee shall be competent to review the NOC granted to the institution concerned and shall be competent to withdraw the same if any of the terms and conditions contained in G.O No. -30720/SME dtd. 23.9.96 and No.-29519/SME dtd. 26.9.98 read with G.O No.-10011/SME dtd. 11.6.2004, is /are violated at any time.
5. The Managing Committee shall be constituted in accordance with the Sec-7 of the Orissa Education Act-1969.

**Grant of N.O.C is also subject to the fulfillment of the following requirements:-**

- i. Own building of the school be completed within a period of one year from the date of issue of NOC as per Govt. order No.5345/SME dtd. 26.3.10.
- ii. The members of the staff of the school be paid salaries at par with the salaries of the State Government with effect from the date of issue of N.O.C.

The organization/individual which has applied for N.O.C will submit an affidavit, within a period of one month to the effect that if she/he will fulfill the above requirements, failing which the N.O.C will be withdrawn.
